### I. PURPOSE

To establish standards regarding an individual receiving services right to receive treatment by spiritual means.

### II. APPLICATION

Populations: **ALL**  
Programs: Direct - **ALL**  
Contract – **ALL**

### III. POLICY

Sanilac CMH programs, both directly operated and contracted, shall recognize and allow individuals receiving services to exercise their right of religious belief and worship.

### IV. DEFINITIONS

Treatment by Spiritual Means - Encompasses a spiritual discipline or a school of thought upon which an individual receiving services wishes to rely to aid in physical or mental recovery and includes easy access, at the individual receiving services' expense, both to printed, recorded or visual material essential or related to treatment by spiritual means and to a symbolic object of similar significance.

### V. STANDARDS

- A. The right to treatment by spiritual means includes the right of individuals receiving services, guardians or parents of a minor to refuse medication or other treatment on spiritual grounds that predate the current allegations of mental illness or developmental disability but does not extend to circumstances where either:
1. A guardian has been empowered by a court to consent to or provide treatment and has done so.
  2. An individual receiving service is dangerous to self or others and it is medically necessary to prevent physical injury.

Sanilac CMH does not provide treatment by spiritual means. Opportunity for contact with agencies providing treatment by spiritual means shall be provided in the same manner as individuals receiving services are permitted to see private mental health professionals.

- B. Right to treatment by spiritual means does not include the right:
  - 1. To use mechanical devices or chemical or organic compounds which are physically harmful.
  - 2. To engage in activity prohibited by law.
  - 3. To engage in an activity which is physically harmful to the individual receiving services or others.
  - 4. To engage in an activity which is inconsistent with court ordered treatment or placement by a person other than the individual receiving services.
- C. When the guardian requests treatment by spiritual means for an individual receiving services, the Care Manager/Supports Coordinator is responsible for assuring the individual receiving services assents.
- D. Individuals receiving services shall not be required or coerced to participate in any religious observance.
- E. Minors shall be afforded the opportunity to participate in religious services and other religious activities in accordance with their individual and family preferences.
- F. When requested, and to the extent feasible, the programs shall assist individuals receiving services in locating and gaining access to religious services and ministrations suited to individual beliefs.
- G. Community religious representatives shall be allowed to visit their parishioners during times arranged with providers that do not disrupt program activities for other participants.
- H. Individuals shall not be denied religious participation as a means of punishment. Participation may be temporarily limited or withheld only for substantial clinical and/or behavioral reasons providing current documentation for the limitation is entered in the clinical record.
- I. Chief Operating Officer or designee has the right to remove an individual receiving service from programming for inappropriate behavior resulting from refusal of medication or other treatment on grounds of spiritual means.
- J. Recourse to court proceedings will be available when there is a refusal of medication or other treatment for a minor.

## **VI. PROCEDURES FOR REQUESTS FOR TREATMENT BY SPIRITUAL MEANS**

### **A. Request**

1. A request for treatment by spiritual means shall be made in writing.
2. The request may be given to any staff person. The request is then to be immediately forwarded to the program supervisor.
3. Notification of the request is to be given to the Care Manager/Supports Coordinator immediately by the program supervisor, first by telephone and then in writing.
4. The written request is to be filed in the individual receiving services' record.

### **B. Approval of the Request**

1. The individual receiving services' Care Manager/Supports Coordinator is responsible for the decision to approve the request for treatment by spiritual means.
2. Approval is to be given only in line with agency policies.
3. Approval is to be given in writing to the individual receiving services and to the person requesting treatment, if other than the individual receiving services. A copy of the approval is to be placed in the individual receiving services' record.
4. The Care Manager/Supports Coordinator is to incorporate the specific request for treatment by spiritual means into the individual receiving services' schedule and assure cooperation of staff.

### **C. Denial of the Request**

1. The individual receiving services' Care Manager/Supports Coordinator is responsible for the decision to deny the request for treatment by spiritual means.
2. Denial is to be made only after examining the request in light of agency policies.
3. The reason for the denial is to be made in writing to the individual receiving services and the person requesting treatment, if other than the individual receiving services. One copy is to be placed in the individual receiving services' resident's case record and a second copy forwarded to the Care Manager/Supports Coordinator's supervisor.
4. The written denial letter is to include an explanation of the individual receiving services' [or other person's] right for an administrative review or to appeal the denial decision.

## **VII. APPEALS**

At the option of the person requesting treatment by spiritual means, Sanilac CMH will provide for the administrative review of the denial of such request.

The individual receiving services or persons acting in their behalf are to be reminded of their right to file a Recipient Rights Complaint if their request for treatment by spiritual means is denied.
